

# The 2019 Wolf Trap Foundation "JET SET TO SINGAPORE" RAFFLE OFFICIAL RULES

ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF TICKETS PURCHASED DURING THE RAFFLE PERIOD, OUT OF 1,200 TICKETS. ALL APPLICABLE FEDERAL, STATE, AND LOCAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

The 2019 Wolf Trap Foundation Jet Set to Singapore Raffle ("Raffle") is being conducted by Wolf Trap Foundation ("Wolf Trap"), located at 1645 Trap Road, Vienna, VA 22182, a not-for-profit charitable organization. All Raffle ticket proceeds benefit Wolf Trap and its arts and education programs. By purchasing a ticket, each purchaser acknowledges having read and agreed to abide by these Official Raffle Rules ("Official Rules").

# **ELIGIBILITY**

Each purchaser of a Raffle ticket must be at least 18 years old and be a legal resident of, and physically located in, Maryland, Virginia or Washington D.C. at time of entry. Tickets may not be purchased as gifts for individuals under 18 years of age. Do not enter the Raffle if you are not a legal resident of, and not located in, Maryland, Virginia or Washington D.C. at the time of entry. Individuals who have been hired to provide security for the Raffle or drawing are not eligible to enter or win. All federal, state, and local laws and regulations apply. The Raffle is void where prohibited by law.

# **PURCHASING A TICKET & RECEIPT ISSUANCE**

The Raffle period shall be from June 5, 2019 at 6:00 PM Eastern Time ("ET") through September 14, 2019 at 10:00 PM Eastern Time ("ET"), or such earlier date as the maximum number (1,200) tickets are sold ("Raffle Period"). All tickets must be purchased by 10:00 PM ET on September 14, 2019 to be eligible to win.

To enter the Raffle, individuals who satisfy the eligibility requirements set forth above may purchase a ticket during the Raffle Period by visiting wolftrap.org/raffle and clicking on the "GET TICKETS" button. Raffle tickets are sold one (1) for \$40 or three (3) for \$100. No other discounts are available on Raffle tickets. An individual may purchase as many tickets as he or she may wish, subject to availability. No other method of entry will be accepted.



When clicking on the "GET TICKETS" button, purchasers are taken to a secure online form (managed by our vendor, Raffle Creator) to conveniently purchase Raffle tickets via credit card. Each online ticket purchaser will be sent a receipt and confirmation of purchase via e-mail that identifies the purchaser's unique Raffle ticket number(s). The original printed Raffle ticket stub will be retained by Wolf Trap and the stub will be entered into the drawing along with the stubs of all other tickets sold.

No more than 1,200 tickets will be sold. All ticket sales are final and non-refundable. Only one eligible person may be entered in the Raffle per ticket sold. If the name of more than one person is provided on a ticket entry form and that ticket is selected as a winning ticket, then the person named first will be deemed as the holder of record of that ticket and declared the winner. The division of any prize among a group of persons purchasing a ticket in common shall be the sole responsibility of the person named as the holder of record of that ticket should that ticket be selected as a winner. Wolf Trap is not responsible for resolving any disputes that may arise from different individuals listed on a winning ticket.

Each Raffle ticket is assigned a randomly generated ticket number. Tickets will not necessarily be sold in sequential order. Wolf Trap reserves the right to reject entry forms submitted with payment that do not constitute "good funds."

Neither Wolf Trap, nor its directors, officers, employees, agents or other representatives, assumes responsibility for lost, late, misdirected, or non-delivered email messages, or any other failure to deliver receipts prior to the drawing deadlines. Wolf Trap assumes no responsibility for and is under no obligation to attempt to process ticket purchase forms that have been incorrectly completed, and these forms will not be entered in to the Raffle drawing.

# **DRAWING & ODDS**

Purchasers of tickets, by participating in the Raffle, release Wolf Trap, its Directors, members and agents from any and all liability, loss, or claim arising out of any Raffle prize. See "Release" section for additional details.

The drawing will take place at the Wolf Trap Ball on Saturday, September 14, 2019 at 10:30 PM. The Ball is held on the Filene Center stage at Wolf Trap National Park for the Performing Arts, located at 1551 Trap Road, Vienna, VA 22182. All Raffle ticket stubs will be placed in a raffle drum and will be thoroughly mixed. Wolf Trap, or its designated representative, will draw the winning Raffle ticket stub at random from the raffle drum. The winner does not need to be present to win.

If your ticket number is drawn and you are not present, Wolf Trap will attempt to contact you within five (5) days after the Raffle drawing (excluding Saturdays, Sundays and holidays) through phone, e-mail, and certified U.S. Mail to award your prize. The winning ticket numbers and names of the winners shall also be posted on



the Wolf Trap Raffle webpage (wolftrap.org/raffle) immediately after the drawing. This information may also be publicized in other media.

Winner must claim and accept the prize within fourteen (14) days of the date notified, or prize will be considered forfeited, and a new winner will be randomly drawn.

Your odds of winning depend on the total number of tickets sold. The maximum number of tickets that will be sold is 1,200. For example, if 700 tickets are sold and you purchase one ticket, your odds are 1 in 700. If the maximum number of tickets is sold and you purchase one ticket, your odds are 1 in 1,200.

# PRIZE DETAILS, VALUES & RESTRICTIONS

One winner will receive the following services and goods included in the 2019 Wolf Trap Ball Jet Set to Singapore Raffle Grand Prize ("Grand Prize").

# **AIRFARE**

• Round-Trip Business Class Airfare for Two (2) on Singapore Airlines valued at \$17,000. Travel on Singapore Airlines must be booked at least three weeks (21 days) prior to travel date, and is subject to seat availability and blackout dates at the time of booking. Both travelers must travel together on the same dates and on the same itinerary. All travel must be completed by September 15, 2020. Applicable airport taxes shall be computed and payable at time of ticket issuance. After the prize tickets are issued, only one date change is permitted within the ticket validity period. Unused tickets shall be forfeited. Prize tickets do not qualify for Frequent Flyer mileage or status credit. Passengers are personally responsible for all travel requirements, including and not limited to passport, visa and health requirements. Other terms and conditions may apply.

The winner, by acceptance of the Grand Prize, grants to Wolf Trap and its designees the right to publicize such winner's name, address (city and state of residence), photograph, voice, statements, and/or other likeness and prize information for advertising, promotional, trade and/or any other purpose in any media or format now known or hereafter devised, throughout the world, in perpetuity, without limitation and without further compensation, consideration, permission or notification, unless prohibited by law.

# **ELIGIBILITY & TAX COMPLIANCE**

Per IRS regulations, Raffle ticket purchases are not tax deductible.

Winners are solely responsible for all income and purchase taxes associated with the prizes awarded and will execute and provide Wolf Trap with a signed statement of eligibility and understanding of these tax obligations, their social security number, and <u>IRS forms 5754</u> and <u>W-2G</u> before prizes are awarded.

Wolf Trap reserves the right, in its sole discretion, to amend, change, cancel or suspend the Raffle (or any portion thereof) at any time, for any reason. Wolf Trap reserves the right, in its sole discretion, to disqualify any entrant found or suspected to be: (i) tampering with the entry process or the operation of the Raffle or (ii) acting in violation of these Official Rules. Any attempt by an entrant to undermine the legitimate operation of the Raffle may be in violation of criminal and civil laws, and Wolf Trap reserves the right to seek damages from any such entrant to the fullest extent permitted by law. These Official Rules shall be governed by and



construed in accordance with the laws of the Commonwealth of Virginia, applicable to contracts entered into and performed exclusively in that jurisdiction.
